Quality / Variety: California Chrome Wheel Inc. uses the most current technology along with strict attention to detail, making the highest quality finishes and products available. This has made us the industry leader. Such finishes include Chrome (Electro Plating), Black Chrome, CalChrome Clear (PVD), Fusion Coating, Custom Polishing, and Custom Finishes. However, all work performed (all finishes, repairs, special services) is done on a "best effort" basis and therefore is custom. This does not guarantee a perfect part, as many variables exist.

Re-Chrome Plating*: Please note that re-chroming a wheel that has been previously chrome plated is a very special procedure. Unlike chrome plating a raw, as-cast, machined, polished, or painted wheel, an existing chrome plated wheel requires additional steps and extra care. Customer expectations may be unrealistic since the new chrome plating will show any imperfections in the base material such as pitting and/or corrosion. Any imperfection in the base material may not be visible until the old plating has been removed. Similar to the damage caused by wood termites, some damage may not be visible from the outside. Aluminum and steel wheels are softer material than the metals plated on them and corrosion will attack the softer metal first. ***Re-chrome work must be paid by check, money order, or wire transfer. No exceptions.**

Multi-Piece Plating: Please review www.calchrome.com/typesofwheel.php to determine what kind of multi-piece wheel you have. Once determined, please contact a sales associate for an explanation of what must be done for chrome plating as well as additional charges that may be incurred.

Pricing Adjustments: Due to the nature of telephone and/or email estimates, the actual processing costs may differ from original assessments. For example: There may be lateral run out (bend) that is not visible during inspection without spinning the wheels at speed. If the cost is different, we will contact you with an exact figure based on our professional examination of the wheels / parts. It is our job as a professional in this field to determine all necessary repairs that need to be done. You as the customer ultimately make the decision on how much work is to be performed.

Packaging Surcharges: Wheels and/or parts that are packed with packing peanuts, foam, or other messy/non-protective methods will be assessed a **\$10 per package fee** for the additional time and clean up required to open your packages. Packing peanuts do not protect your wheels. Using one of these packing materials may delay the opening and inspection of your parts. Return Shipping: California Chrome Wheel does not accept customer provided return labels and / or customer provided prepaid return shipping. Please arrange all shipping with your sales contact. All shipping quotes provided by CalChrome include the use of our custom oversized double walled 275# boxes, custom injection foam molds, and full insurance. We will not compromise the packing method to lower the shipping quote. We want you to receive the completed part in perfect condition.
